NOTICE OF RACE

The notation **[NP]** in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1.

The notation **[SP]** in a rule in the SI means that a breach of that rule denotes a rule may, at the discretion of the race committee, be a standard penalty without a hearing

1. ORGANIZING AUTHORITY

The Organizing Authority (OA) is the Yacht Club Sanremo under the aegis of the Federazione Italiana Vela.

2. RULES

- 2.1 The event will be governed by the rules as defined in the RRS 2025-2028
- 2.2 Appendix T of RRS (Arbitrage)
- 2.3 Appendix P of RRS (Specials procedures for Rule 42).
- 2.4 For the Italians competitors the "Normativa" of the Italian Sailing Federation in force will apply.
- 2.5 Class rules
- 2.6 The official language of the event is English
- 2.7 In case of conflict between NOR and SI, the SI and the subsequent notice will take precedence; this modify RRS 63.5(c)(2)

3. SAILING ISTRUCTIONS

- 3.1 The sailing instructions will be available on the online Official Notice Board (ONB) since 19th February 2025 at <https://www.racingrulesofsailing.org/documents/10331/event> .

4. COMMUNICATIONS

- 4.1 The Official Notice Board, communications to competitors and from competitors to the OA, CR and Jury shall be done only as an Online Official Notice Board, available at the following link <https://www.racingrulesofsailing.org/documents/10331/event> or QR code:



FOR FULL EFFICENCY OF THE DESCRIBED SYSTEM, IT IS COMPULSORY THAT ALL CREWS (HELMSMAN AND BOWMAN) WILL INFORM OA BY THE ENTRY FORM THE OWN EMAIL ADDRESS AND WHATAPP PHONE NUMBER.

Each crew is responsible to adjust yourself to such system.

5. ELIGIBILITY AND ENTRY

5.1 WS Regulation 19 "Eligibility Code" applies

5.2 The event is open to following classes: 420 Men/Mixed and Ladies, 470 Mixed, Man and Women.

5.3 Eligible boats may enter as per following point 6.

6. FEES

The Entry will be done only by the website of the Italian Sailing Federation, as per the following link: <https://federvela.coninet.it/user/login?destination=#/benvenuto> , by February 15th, 2025, with all required attachment, Insurance certificate (see bottom) and valid measurement certificate.

The entry fee is euro 250.

For the inscriptions and payment received before February 10th, 2025 the entry fee is reduced to euro 200.

The inscriptions received after February 15th, 2025 will be accepted only under unquestionable discretion of the Organizing Authority by a further penalty of 50 euro.

Payment of the registration fee is not refundable.

7. ADVERTISING AND OTHER IDENTIFICATION

7.1 Boats may be required to display advertising and identification stickers chosen and supplied by the organizing authority, in accordance with Advertising Code, Regulation 20.4 WS

7.2 The Organizing Authority reserves the right to refuse advertising by a boat or competitor when it is in conflict with the laws of the Italian government or Italian Sailing Federation.

7.3 **[SP]** Boats of 470 Women and 420 Ladies classes shall carry the red square identification on both side of the mainsail.

8. INSURANCE

8.1 All boats competing in this event shall have third party insurance cover not less **than 1.500,000 EURO** for any accident.

8.2 Each competitor must produce at Registration the form attached to this NOR duly filled: entries of competitors not holding such document will be not accepted. A copy of the Insurance shall be preliminary sent during the on-line registration and then also produced at Registration office during the final Registration procedures.

8.3 This rule not apply to the competitors holding the card FIV PLUS.

9. QUALIFYING SERIES AND FINAL SERIES

8.1 The organizing authority reserves the right to divide the 420 Open fleet and run qualifying and final series, according to the number of entries. Details will be given on the SI, and announced within 10:30 am of Thursday 20th.

13. THE COURSES

13.1 Details of Courses will be given in the Sailing Instructions

14. SCORING

14.1 One race is required to be completed to constitute a series.

14.2 Discards:

- When from 1 to 4 races have been completed, a boat's series score will be the total of her race scores.
- When from 5 to 11 valid races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

15. BOATS OF SUPPORT PERSONS

15.1 Boats of support persons shall be marked with a flag or sticker supplied by the organization and shall register at the registration desk before 10.00 a.m. of 00th February.

15.2 Evidence of Third Party insurance for each support boat shall be produced during registration.

16. BERTHING

15.1 Boats shall be kept in their assigned area in the boat park.

16. PRIZES

420 CLASS:

- Will be awarded: the first five boats classified for each group (Gold open and Women);
- The first crew Under 17 (Open and Women);
- The first three mixed crew classified.

470 class:

- Will be awarded: the first three mixed crew classified.
- The first man and the first woman

17. DISCLAIMER OF LIABILITY

17.1 RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone". The participants are aware that the sailing activity falls within those governed by article 2050 of the Italian Civil Code therefore all Italian participants must have a valid FIV membership, included medical validation, that guarantees accident coverage, including death and permanent disability.

17.2 Not Italian competitors must comply with the requirements of their MNA, if any, and be in possession of accident coverage, including death and permanent disability as per current FIV

regulations. The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

18. RIGHTS TO USE NAME AND LIKENESS

18.1 In participating in an event, a competitor automatically grants to the Organizing Authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures, still pictures and live, taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates and in all material related to the said event without compensation.

19. ENVIRONMENTAL RESPONSIBILITY

19.1 Recalling the Basic Principle that quotes: "Participants are encouraged to minimize any negative environmental impact of the sport of sailing", it is recommended the utmost attention to environmental protection in all moments that accompany the practice of the sport of sailing before, during and after the event. In particular, attention is drawn to RRS 47 – Waste Disposal – which quotes: "Competitors and support persons must not deliberately throw waste into the water. This rule always applies when in the water. The penalty for an infraction of this rule may be less than the disqualification."
