NOTICE OF RACE

The notations in a rule: **[DP]** means that a penalty for breach of that rule may, at the discretion of the Jury, be less than disqualification. **[NP]** means that a boat can't protest for a breach of this rule.

1.ORGANIZING AUTHORITY

1.1 The Organizing Authority is Yacht Club Sanremo, in conjunction with International Dragon Association (IDA) and Circolo Velico Capoverde.

2.RULES

2.1The regatta will be governed by the rules as defined in The WS Racing Rules of Sailing 2025-2028.

2.4 In the event of conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions shall prevail. This changes RRS 63.5 (c) (2).

2.5 If there is a conflict between languages the English text will take precedence.

2.6 - The weight crew restrictions of the class rule 13.30 not apply.

2.7 – For the Italians competitors the "Normativa" of the National Authority FIV (Italian Sailing Federation) will apply.

2.8 The title of "Italian Championship" will be assigned to the first Italian Helmsman classified in the final overall ranking

3. COMMUNICATIONS

3.1 The Official Notice Board (ONB), communication to competitors and from competitors to the OA, CR and Jury, shall be done only as an Online Official Notice Board, available at the following link: <u>https://www.racingrulesofsailing.org/documents/10568/event</u> or QR Code:



4. ELIGIBILITY

4.1 - WS Regulation 19 "Eligibility Code" applies.

4.2 - Only International Dragon Class yachts holding valid Measurement Certificates shall compete.

5. ENTRIES AND FEES.

5.1 The Entry will be done only by the website of the Italian Sailing Federation as follows:

- For the Italians competitors by the link <u>https://federvela.coninet.it</u>
- For the foreign competitors by the link <u>https://federvela.coninet.it/iscrizioneatletistranieri</u>. In the window that will appear to write only "DRAGON" in the space "EVENT NAME" and after to click over "Event search"
- 5.2 The entries as above shall be posted by March 12th, 2025,

The entry fee is euro 600.

The entries received after March 12th, 2025 will be accepted only under unquestionable discretion of the Organizing Authority by a further penalty of 100 euro.

- 5.3 The entry shall be completed with:
- <u>Copy insurance's company statement as per annex</u>, with a minimum cover of € 1.500.000,00 per event.
- Copy of valid measurement certificate.
- The entry fee can to be paid in a second time.
- 5.4 Payment can be made by Bank:

The entry fee includes crane fees for one hauling-in and one hauling-out, and all social events as described in section 7 "Race Schedule". Payment of the entry is not refundable.

5.5 The "Corinthian" crews, i.e. crews composed by Group 1 sailors only, shall declare their intention to compete in the Corinthian classification in the entry form, as per Regulation 22 "Sailor Categorization Code" (Ref. WS Regulation 22.4.5).

6. MEASUREMENT AND EQUIPMENT INSPECTIONS

6.1 - Inspections may be carried out on boats and/or equipment prior, during and after the races following the request of the Race Committee or Jury.

6.2 - No measurement will be available at the event. All boats and sails shall be already measured and approved to be in compliance with Class Rules in advance to the event.

7. RACE SCHEDULE

- 7.1 8 Races are scheduled and no more than 2 races shall be raced on per day.
- 7.2 Overall Event Schedule:

- Sunday 23rd March No warning signal will be made after 2.30 pm.

- ASAP after races daily and final, there will be the price giving ceremony.

7.3 - The Race Committee may sail up to two races per day. A third race may be sailed in case of delay or forecast of delay on the schedule. This third race will be signaled by the RC displaying the flag "G" after the end of the second daily race.

7.4 - The scheduled time of the first warning signal of each day after the first day will be posted on the ONB before 08.00 pm of the previous day. Where no new notice is posted, the first warning signal of the next day will be the same as the warning signal of the previous day.

7.5 - The Organizing Committee may modify the race schedule in case of adverse weather or any other circumstance.

8. COURSES

Races will be windward/leeward courses in the Gulf of Sanremo as described in the Sailing Instructions

9. PRIZES

Prizes will be awarded to: - The first three boats overall.- Others eventual prizes at OA discretion

10. SAILING INSTRUCTIONS

Sailing Instructions shall be posted on the ONB.

11. SCORING

11.1 - A maximum of eight (8) races will be sailed. The low points scoring system of RRS A will apply.

11.2 When fewer than 5 races have been completed, a boat's series score will be the total of her race scores; when 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

11.3 Only one race completed will be enough to constitute the series.

12. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 3, Decision to Race. The Organizing Authority will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.

13. SUPPORT BOATS

13.1 All support boats including coach, press, private and spectator boats will have to register during the registration period and have to pay a support boat fee of $150 \notin$ for the time of the event. This fee does include craning and berthing.

13.2 Support boats shall be marked with his country flag. Additionally, the OA may request for this boats to use additional markers or flags.

13.3 Support boats must comply with the Support Boats Regulation, which will be delivered upon the boat registration.

14.4 In the event of an emergency the Race Committee may request support boats for their assistance

14. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000€ per event or the equivalent. Alternatively, you can fill in the attached form to be signed and stamped by your Insurance Company.

15. MEDIA RIGHTS

By entering this event yacht owners, their crew members, and guests give the Organizing Authority and its sponsors the rights and authorization to publish and/or distribute, via any media, photographs and videos of people and boats made during the event, even for press release and/or advertising.

16 ENVIRONMENTAL RESPONSIBILITY

Recalling the Basic Principle that quotes: "Participants are encouraged to minimize any negative environmental impact of the sport of sailing", it is recommended the utmost attention to environmental protection in all moments that accompany the practice of the sport of sailing before, during and after the event. In particular attention is drawn to RRS 47 – Waste Disposal – which quotes: "Competitors and support persons must not deliberately throw waste into the water. This rule always applies when in the water. The penalty for an infraction of this rule may be less than the disqualification."
